The Company hereby announces that during the meeting of its Board of Directors held on 28<sup>th</sup> February 2025, the Company’s Annual Report and Audited Financial Statements for the financial year ended 31<sup>st</sup> October 2024 were approved.

The Board of Directors shall be recommending to the Annual General Meeting of the Company that no dividend be declared in respect of the financial year ended 31<sup>st</sup> October 2024.

The Company notes that, in terms of Capital Markets Rule 5.16.24, the Board of Directors has determined that the results set out in the aforesaid Annual Report and Audited Financial Statements for the financial year ended 31<sup>st</sup> October 2024 differ by more than ten percent (10%) from previously published forecast financial information featured in the Financial Analysis Summary dated 22<sup>nd</sup> April 2024. The variance threshold was surpassed due to foreign exchange movements.

The Board of Directors resolved that the aforesaid Annual Report and Audited Financial Statements be submitted to the shareholders of the Company for their approval at the forthcoming Annual General Meeting scheduled to take place on 20<sup>th</sup> March 2025.
